No. GE (GL) S-07/2016- 6796 /R&D.M dated 27-2-16

Whereas the period of limitation provided under para (i) of the proviso to clause 1 of Schedule V of the Odisha Government Land Settlement Rules, 1983 was extended for a period of two years with effect from the 17th February, 2014 under the notification of the Government of Odisha in the Revenue and Disaster Management Department No. GE (GL)-S-13/2014-23934/R&DM, dated the 13th August, 2014 published in the Extraordinary issue of The Odisha Gazette No. 1373 dated the 20th August, 2014;

And whereas the State Government are satisfied that there exists sufficient reasons for further extending the period of limitation as so extended;

Now, therefore, in exercise of the powers conferred by para (i) of the proviso to clause 1 of Schedule V of the Odisha Government Land Settlement Rules, 1983, the State Government do hereby extend the period of limitation for a further period of two years with effect from the 17th February, 2016.
