No. CON-R-24/2010 1091 /R(CS).., Pending receipt of concurrence of Orissa Public Service Commission, Sri Pramod Kumar Mishra (RR-91), holding the post of OAS-I(JB) consequent to restructuring of Orissa Administrative Service with effect from 28.02.2009 at present Tahasildar, Patna, Dist: Keonjhar is promoted to the rank of OAS-I(JB) on adhoc basis for a period not exceeding to one year or till the recommendation of Orissa Public Service Commission is received which ever is earlier.

His promotion to the rank of OAS-I(JB) is notional with effect from the date his junior Sri Shyambhakta Mishra promoted to the rank of OAS-I(JB) on 24.09.2007 vide this Department Notification No.30656/R(CS), dt. 02.08.2007 in the recruitment year, 2006. On promotion the inter-seniority of Sri Pramod Kumar Mishra is fixed provisionally above Sri Shyambhakta Mishra, Sl.No.369 and below Sri Bijay Kumar Khandayat Ray, Sl.No.368 of the provisional gradation list of OAS-I(JB) issued vide this Department Notification No.594/R(CS), dt. 29.03.2011. Sri Mishra is not entitled for payment of any arrear financial benefit for the period which he has not actually worked in the promotional post of OAS-I(JB). His pay is to be fixed notionally from the date of his junior Sri Shyambhakta Mishra joined in the rank of OAS-I(JB) on 24.09.2007.
