No.CON-R-06/2014 1574 /R(CS), In pursuance of Rule- 4(a)(ii) of OAS (Method of Recruitment and Conditions of Service) Rules, 2011 and pending concurrence of Odisha Public Service Commission, the State Government do hereby appoint Sri Sarat Kumar Mallick, Odisha Revenue Service Group "B", Assistant Settlement Officer, Jeypore (on deputation to Kandhamal Settlement Office) on adhoc basis to OAS Group "A" (Junior Branch) in the scale of pay of Rs. 15,600/- to 39,100/- + Grade Pay of Rs. 5,400/- by way of Promotion in respect of the Recruitment Year, 2011 for the period not exceeding one year or until receipt of recommendation of Odisha Public Service Commission, whichever is earlier from the date of his joining in the post.

2. On his appointment to OAS Group "A" (Junior Branch), he is posted as Tahasildar, Nilagiri. His pay shall be fixed notionally as per the provisional Gradation list with effect from 05.12.2013 i.e. the date of promotion of his junior Sri Tarini Suna, ORS promoted to the said rank. He is not entitled to get any arrear financial benefits in the promotional post as he has not worked in the said post. Inter-se-seniority of Sri Mallick shall be fixed latter on after outcome of the W.P.(C) No. 21849/2013 filed by Sri Sailendra Kumar Samal-versus- State of Odisha and others.
