No. RDM-CON-PM-0065-2019 17216 /R&DM, In pursuance of Odisha Revenue Service (Recruitment) Rules, 2011, the State Government do hereby appoint the following 16 (sixteen) candidates who have come out successful in Odisha Civil Services Examination, 2017 conducted by Odisha Public Service Commission, Cuttack to Odisha Revenue Service, Group-B in Cell-1, Level-10 of the Pay Matrix under ORSP Rules- 2017.

They shall be on probation for a period of two years and their appointment is subject to verification of antecedents, physical fitness and verification of original certificates in cases where it has not been done. On receipt of adverse report on character and antecedents, his/ her services shall be terminated forthwith in accordance with the provisions laid down in sub-clause b (ii) of clause (h) of Explanation under rule-13 of the Orissa Civil Services (Classification, Control and Appeal) Rules, 1962 reinforced in G.A. Department Resolution No. 34438/Gen., dated 20.11.1999.

On being appointed to ORS Group-B posts, the candidates are hereby posted as Training Reserve Officers in the districts mentioned against each.

The candidates are instructed to join in the respective District Offices (Office of the Collector & District Magistrate) within 15 days from the date of issue of this appointment order.


