In pursuance of General Administration Department Resolution No.5719/Gen, dated: 28.02.2009, restructuring the Cadre of Orissa Administrative Service and constitution of the Orissa Revenue Service, Revenue and Disaster Management Department issued Resolution No.1234/R(CS)., dated: 20.08.2009 and Office Memorandum No.1176/R&DM, dated: 10.08.2010. In Partial modification of the Resolutions and the Office Memorandum issued by Revenue and Disaster Management Department, Government after careful consideration have been pleased to decide as follows:

- 1. The pay of all OAS-I(JB) Officers including the officers holding the post of OAS-I(JB) in the pay Band-2 of scale of pay Rs.9,300/- to Rs.34,800/- with Grade Pay of Rs.5,400/- and the officers holding the post of OAS-II in Pay Band-2 of scale of pay of Rs.9,300/- to Rs.34,800/- with Grade Pay of Rs.4,600/-, the pay of the officers who are coming under the said coverage shall be fixed under the provision of Rule-13 of Orissa Revised Scale of Pay Rules, 2008.
- 2. 3% incremental benefit shall be given to all OAS Officers who are borne in the restructured cadre with effect from 28.02.2009 instead of 25.05.2009 or from the date as per the option exercised by the officers in the prescribed proforma within one month from the date of issue of this Resolution.
- 3. If the pay in the pay band after adding 3% incremental benefit becomes less than the minimum of the basic pay band i.e. Rs.15,600/- then the pay shall be fixed at the minimum i.e. Rs. 15,600/- with grade pay of Rs.5,400/-.
- 4. The next date of increment of the said OAS Officers will fall due on the completion of one year from the date of such fixation of pay.

- 5. This has been concurred in by the Finance Department vide their U.O.R. No.191-CS-1-I, dated: 08.06,2010.
- 6. This will come into force with effect from the date of issue of this Resolution.
