

No.III-EPT-22/2015- 2033 /R&DM, In pursuance of Rule- 4(a)(ii) of OAS (Method of Recruitment and Conditions of Service) Rules, 2011 and pending concurrence of Odisha Public Service Commission, the State Government do hereby appoint Sri Siddhartha Shankar Pani, Odisha Revenue Service(ORS) Group "B" officer, ASO, Major Settlement, Puri to OAS Group "A" (Junior Branch) in the scale of pay of Rs.15600-39100/- with Grade Pay Rs. 5,400/- by way of Promotion against the Recruitment Year, 2011 for a period not exceeding one year or till receipt of recommendation of Odisha Public Service Commission, whichever is earlier from the date of their joining in the post.

2. On appointment to OAS Group "A" (Junior Branch), his services are placed with Industries Department for posting as Land Officer, IDCO, Bhubaneswar. His pay shall be fixed notionally with effect from the date of promotion of his junior promoted to the said rank. He is not entitled to any arrear financial benefits in the promotional post as he has not worked in the same post.

3. Inter-Se-seniority of Sri Pani shall be fixed later on after outcome of the WP(C) No. 21849/2013 filed by Sri Sailendra Kumar Samal -vrs- State of Odisha and others.






