Sir,

I am directed to say that Revenue & Disaster Management Department of late, have taken so many e-Governance initiatives such as :- on-line Mutation, Revenue Court Case Monitoring System(RCCMS), Court Case Monitoring System(CCMS), Bhu Naksha, Data Management System(DMS) and Manual of Tahasil Account(MTA) which are implemented in all the 317 Tahasils across the state. The basic objective of these initiatives is to provide various services to the people promptly, effectively and without involvement of middlemen in the delivery mechanism.

Revenue Officers' Training Institute (ROTI), Bhubaneswar is the right venue where all these initiatives can be trained /disseminated to the Revenue Officers like OAS Officers. As all the facilities are currently available at ROTI, OAS-A(JB) Officers while undergoing Institutional Training at Gopabandhu Academy of Administration(GAA) would be imparted for such training on the above e-Governance for a week. Academy will make necessary arrangements for their conveyance while training .

Further, other officers who are in charge of Tahasils as Tahasildars would be drafted for such training in a phased manner in consultation with Director, ROTI.
