Sub: Institutional Training of OAS Group-A (JB) Officers at Gopabandhu Academy of Administration, Odisha, Bhubaneswar.


Madam,




Sir,

It has been brought to my notice that Revenue & Disaster Management Department has organised training of OAS officers at Gopabandhu Academy of Administration vide its letter no. 21941/R&DM dated 19th June 2018 (copy enclosed). Most of the officers drafted for the said training are posted as Tahsildars, BDOs, Deputy Collectors and it is very likely that many of them have been declared as AEROs and in few cases EROs. You are aware that the Special Summary Revision (SSR) of Intensive Nature of the Electoral Rolls has been started from 15th of June 2018. Relieve of any officer for any reasons from that office will seriously hamper the Revision activities.

Hence you are hereby instructed to ensure that any officer, who is connected, either directly or indirectly with the SSR, is NOT relieved from your district. Please ensure that if any officer has, in the meantime, been relieved by you, he/ she must be asked forthwith to report back for duties.
