





The ORS Officers involved with Special Summary Revision of Photo Electoral Roll shall not be relieved till completion of the process.


Other ORS Officers may be relieved w.e.f. 25.07.2018 without waiting for substitute so as to enable them to join their place of posting by 01.08.2018.
