

In pursuance of Rule -4(b) of Odisha Revenue Service, Group-'B' (Recruitment) Rules, 2011 and pending receipt of concurrence of Odisha Public Service Commission followed by a compliance to the orders of the Hon'ble OAT, Bhubaneswar vide O.A. No. 1210/2012, Government do hereby appoint to Sri Yudhistir Meher, Senior Clerk of Tahasil Office, Subarnapur as Assistant Collector, Collectorate, Boudh by way of Promotion against the Recruitment year, 2011 in the ORS, Group-'B' cadre in the scale of pay of Rs.9300-34,800 with Grade pay of Rs. 4600/- on adhoc basis for a period not exceeding to one year or till receipt of concurrence of Odisha Public Service Commission which ever is earlier.
