
With reference to this Department letter No.26195/R&DM dated 08.08.2017 on the subject cited above, I am directed to say that, approved training programme of 05 days Orientation Training of **Untrained Revenue Field Officers** viz; RIs/ARIs & Amins was sent to you with request to communicate OSD-cum-Director, ROTI, Gothapatna, Bhubaneswar, Deputy Directors of 02 RITIs and all Settlement Officers for their reference/guidance during Orientation Training commencing from 28.08.2017/30.08.2017 to 06.01.2017.

Now, it has come to the notice of this Department that majority of the districts have not sent cent percent un-trained personnel for training in the 1st Batch in their assigned training centres. Secondly, some districts have relieved trained staff for Orientation training. Number of trainees reported for training for 1st Batch is enclosed for your reference.

In view of the above, you are requested to issue suitable instructions that District Administration shall have to ensure cent percent joining of un-trained personnel drafted for training in the 2nd Batch and successive Batches. Non-joining of approved un-trained staff in the 2nd and successive Batches in the tagged Training centres would be viewed seriously for which Addl. Distt. Magistrates be held accountable and they have to arrange training of the un-trained personnel at the district level cost of which would be borne by them (ADMs).
