No.III-EPT-22/2015- 29665 /R&DM, In pursuance of Rule- 4(a)(ii) of OAS (Method of Recruitment and Conditions of Service) Rules, 2011 and pending concurrence of Odisha Public Service Commission, the State Government do hereby appoint Sri Surendra Meher, Odisha Revenue Service(ORS) Group "B", ASO, Cuttack-Puri Major Settlement, Cuttack to OAS Group "A" (Junior Branch) in the scale of pay of Rs.9300-34800/- with Grade Pay of Rs. 5,400/- by way of Promotion against the Recruitment Year, 2014 for a period not exceeding one year or till receipt of recommendation of Odisha Public Service Commission, whichever is earlier from the date of their joining in the post. 


