No. CON-R-53/2014 298 /R(CS), In pursuance of orders of the Hon'ble Odisha Administrative Tribunal, Bhubaneswar dated 26.06.2014 passed in the O.A. No.3690/2013 and Rule-3(b) of Orissa Administrative Service Class-II (Recruitment) Rules, 1978 and pending concurrence of Odisha Public Service Commission, the State Government do hereby appoint Sri Bijay Kumar Mohanty, Assistant Consolidation Officer on ad-hoc basis to OAS Class-II by way of promotion in respect of Recruitment Year, 2001-2005 for the period not exceeding one year or until receipt of recommendation of Odisha Public Service Commission whichever is earlier from the date of joining in the post. The appointment of Sri Mohanty is subject to outcome of the O.A. No. 438(C)/2009 filed by Sri Gopabandhu Bhosagar-versus- State of Odisha and others.

Further, consequent upon restructure of OAS with effect from 28.02.2009 vide General Administration Department Resolution No. 5719/Gen, dated 28.02.2009 followed by Revenue and Disaster Management Department Resolution No.1824/R(CS), dated 24.11.2010, Sri Mohanty is appointed in OAS Group "A" (Junior Branch) and is entitled to get pay fixation benefit in the said cadre from the date of actual joining.

On appointment to OAS Group "A" (Junior Branch), Sri Mohanty is posted as Tahasildar, Binjharpur, Dist: Jajpur. Sri Mohanty is allowed to continue in ongoing settlement operation till completion of pending consolidation work under his charge in Dasarathpur Consolidation of Holdings Camp. He is entitled to draw salary in the promotional post from the date of his joining. The inter-se-seniority of Sri Mohanty in the rank of OAS Group "A" (Junior Branch) is to be fixed after outcome of O.A. No. 438(C)/2009 filed by Sri Gopabandhu Bhosagar-versus-State of Odisha and others.

This is in compliance to the order of the Hon'ble Odisha Administrative Tribunal, Bhubaneswar dated 26.06.2014 passed in the O.A. No.3690/2013 and C.P. No. 587/2014 arising out of the said O.A.
