No. CON-R-181/2013 324 /R(CS), Sri Gangadhar Patra belongs to RR-1984 batch OAS Officer. Due to pendency of Disciplinary Proceeding under Rule-15 and vigilance case against him, his promotion to the rank of OAS-I (JB) in the D.P.C. held during the year, 2006 was kept in sealed cover as per the provisions contained in General Administration Department Office Memorandum No. 3928/Gen., dated: 18.02.1994 and read with Office Memorandum No. 14640/Gen., dated: 04.07.1995. But one of his junior Sri Rashmi Ranjan Das was considered suitable in the D.P.C. held for the year, 2006 and promoted to OAS-I (JB) on 28.10.2006.

After careful consideration of the representation of Sri Gangadhar Patra and disposal of disciplinary proceeding and vigilance case against him, Government have been pleased to promote him notionally to the rank of OAS-I (JB) with effect from 28.10.2006 i.e. the date of promotion of his junior Sri Rashmi Ranjan Das promoted to the said post. On notional promotion with effect from 28.10.2006 to the rank of OAS-I (JB), he is not entitled to get any arrear financial benefits attached to the post as he has not worked in the promotional post. On notional promotion to the rank of OAS-I (JB) the inter-se-seniority of Sri Gangadhar Patra is fixed above Sri Rashmi Ranjan Das, RR- 1984, Sl. No. 17 and below Smt. Jayanti Singh, RR-1984, Sl. No. 16 in the Provisional Gradation list of OAS Group "A" (Junior Branch) 2014 published vide Revenue and Disaster Management Department Order No. 80/R(CS), dated 05.02.2014. Therefore, a new serial number 16(A) is assigned to Sri Gangadhar Patra in the said Gradation list.
