No. CON-R-113/2013 455/R(CS), Sri Subash Chandra Sahoo belongs to RR-1978 batch OAS Officer. Due to pendency of Disciplinary Proceeding under Rule-15 of OCS (CC&A) Rules, 1962 and Vigilance Case against him, his promotion to the rank of OAS-I (JB) in the D.P.C. held during the year, 1996 and 1997 were kept in sealed covers as per the provisions contained in General Administration Department Office Memorandum No. 3928/Gen., dated: 18.02.1994 and read with Office Memorandum No. 14640/Gen., dated: 04.06.1995. But some of his junior were considered suitable in the D.P.C. held for the year, 1996 and 1997 and promoted to OAS-I (JB).

After careful consideration of the representation of Sri Subash Chandra Sahoo and complete exoneration from disciplinary proceeding and acquittal from Vigilance case drawn against him, the seal cover proceedings dated 03.12.1996, 04.12.1996 and 29.06.1998 were opened. On opening of the seal cover proceedings, Sri Sahoo found unsuitable in the D.P.C. held on 03.12.1996 and 04.12.1996. Therefore, his promotion to the rank of OAS-I (JB) could not be considered for the said D.P.C. But he found suitable for the D.P.C. held on 29.06.1998. Basing on this Government has been pleased to promote him notionally to the rank of OAS-I (JB) with effect from 29.06.1998 i.e. the date of promotion of his junior Sri Bajel Majhi promoted to the said post. On notional promotion with effect from 29.06.1998 to the rank of OAS-I (JB), he is not entitled to get any arrear financial benefits attached to the post as he has not worked in the promotional post. On notional promotion to the rank of OAS-I (JB) the inter-se-seniority of Sri Subash Chandra Sahoo is fixed above Sri Bajel Majhi, RR- 1978, Sl. No. 197 and below Sri Durga Charan Mohanty, RR-1978, Sl. No. 196 in the OAS-I (JB) Gradation list of 2001 published vide Revenue and Disaster Management Department Order No. 302/R(CS), dated 16.05.2001. Therefore, a new serial number 196(A) is assigned to Sri Subash Chandra Sahoo in the said Gradation list.


