## Sub: Re-employment of retired OAS Officers

Sir, am directed to say that Government have been pleased to place the services of the following retired OAS officer at your disposal for re-employment as OSD on contractual basis for a period of one year or filling up of the posts, whichever is earlier. The period of engagement can be extended for a further period of one year subject to satisfactory performance and shall not be extended beyond the age of 65 years. Further appropriate steps may be taken at their level as indicated below under intimation to Revenue & D.M. Department.

1. Administrative Department are requested to issue re-employment orders to the selected retired OAS Officer as per the terms & conditions laid down in General Administration Department Resolution No. 23750/Gen. dtd. 27.08.2014 obtaining concurrence / approval of Finance Department, if not taken earlier in the

matter.

2. In case it is found that Departmental Proceedings or Criminal cases are contemplated/ pending against any Officer or he has been penalised for misconduct during the period of preceding five years in Departmental Proceedings or Criminal cases, he will not be re-employed / he will be disengaged.

3. Re-employed officers will be entitled to pay and other allowances as determined by the Administrative Department/Appointing Authority with the concurrence of the Finance Department. The pay of these retired reemployed OAS Officers, who will be appointed as OSD , may be fixed in term of Para-1(a) of Finance Department O.M. No. 5554 dated 16.02.2012, obtaining concurrence of Finance Department by the Administrative Department.

4. The above posting is subject to clearance of the G.A. Department / G.A. (Vigilance) Department.
