No. CON-R-II- 31/2013 573 /R(CS), As a compliance to the orders of the Hon'ble Odisha Administrative Tribunal, Cuttack in O.A. No. 178(C)/2008 and a bunch of cases and in pursuance of Rule 3(b) of OAS Class-II (Recruitment Rules, 1978 and read with Regulation II of OAS Class-II (Appointment by Promotion and Selection), 1978 followed by approval of the Cabinet, the services of Sri Khetrarohan Pattnaik who was earlier appointed in OAS Class-II on adhoc basis vide Revenue and Disaster Management Department Notification No. 1194/R(CS), dated: 28.08.1995 by way of Promotion against the Recruitment Year, 1994 is now regularized against the aforesaid year of recruitment i.e. with effect from 27.09.1995, the date of joining in the said post.


