No. 178(C)/2008 and a bunch of cases and in pursuance of Rule 3(b) of OAS Class-II (Recruitment Rules, 1978 and read with Regulation II of OAS Class-II (Appointment by Promotion and Selection), 1978 followed by approval of the Cabinet, the services of Late Ajaya Krushna Das who was earlier appointed in OAS Class-II on adhoc basis vide Revenue and Disaster Management Department Notification No. 1194/R(CS), dated: 28.08.1995 by way of Promotion against the Recruitment Year, 1994 is now regularized against the aforesaid year of recruitment i.e. with effect from 26.09.1995, the date of joining in the said post.

2. On regularization of services of Late Ajaya Krushna Das, Ex-OAS and ACO, Headquarters, Cuttack sadar in OAS-II cadre, his inter-se-seniority is fixed above Sri Satyanarayan Mohapatra and below Sri Rabindra Chandra Pradhan in the OAS-II gradation list of 2007.
