No. RDM-CON-MISC-0014-2018 6570 /R&DM, In pursuance of Odisha Revenue Service (Recruitment) Rules, 2011, the State Government do hereby appoint the following candidates to **Odisha Revenue Service, Group-B** in Cell-1, Level-10 of the Pay Matrix under ORSP Rules 2017 as per revised result of the Odisha Civil Services Examination, 2011 conducted by Odisha Public Service Commission, Cuttack, who were earlier appointed to OT&AS/OPS/OCS.

They shall be on probation for a period of two years and their appointment is subject to verification of antecedent, physical fitness and verification of original certificates in cases where it has not been done. Adverse report on character and antecedents, if received, will be dealt as per General Administration Department Resolution No. 34438 dated 20.11.1999.

These appointments are subject to final outcome of the decision of Hon'ble Odisha Administrative Tribunal in QA.No. 3042(C)/2016, QA.No.3043(C)/2016 and other related court cases.
