No. RDM-CON-MISC-0016-2018 6700 /R&DM, In pursuance of Odisha Revenue Service (Recruitment) Rules, 2011, the State Government do hereby appoint the following candidates to Odisha Revenue Service, Group-B in Cell-1, Level-10 of the Pay Matrix under ORSP Rules- 2017 as per result of the Odisha Civil Services Examination, 2015 conducted by the Odisha Public Service Commission, Cuttack.

They shall be on probation for a period of two years and their appointment is subject to verification of antecedent, physical fitness and verification of original certificates in cases where it has not been done. Adverse report on character and antecedents, if received, will be dealt as per General Administration Department Resolution No. 34433 dated 20.11.1999.

These appointments are subject to final outcome of the decision of Hon'ble Odisha Administrative Tribunal in O.A. No. 497(C)/2017 (for all candidates), O.A. No. 303(C)/2017 & O.A. No. 541(C)/2017 (for Ex-Serviceman candidates), O.A. No. 3856(C)/2015 (for SEBC candidates) and other related court cases.


