RESOLUTION

No- RDM-GOEB-MISC-0039-2015- 37203 / R&DM, Dated 27 NOV 2019

1. Short title and Commencement.—(1) These rules may be called the Odisha Miscellaneous Certificate (Amendment) Rules, 2019.

(2) They shall come into force on the date of their publication in the Odisha Gazette.

2. In the Odisha Miscellaneous Certificate Rules, 2019, hereinafter referred to as the said rules, in rule 6, after sub-rule (3), the following sub-rule shall be inserted, namely:-

“(3a) The Revenue Officer while issuing certificate in Form No. I, III, IV, V, VI & VII, shall affix the photograph of the applicant in such certificate.”

3. In the said rules, in Form No. 1, in serial No. 3, under the heading of Present address, after the expression “State”, the following shall be inserted, namely:-

“Residing For : \_\_\_\_\_ year(s) & \_\_\_\_\_ month(s)”

4. (a) In the said rules, in Form No. 3, in serial No. 1, under the heading of Personal detail, after the expression “Age”, the following shall be inserted, namely:-


“Mother’s Name \_\_\_\_\_”; and

(b) under the heading “ Declaration” for the word “suppressed”, the words and symbol “suppressed / misrepresented” shall be substituted.
