In exercise of the powers conferred by section 78 readwith section 79 of the Registration Act, 1908 (16 of 1908), the State Government do hereby make the following amendments in the existing table of fees published under the notification of the Government of Odisha in the erstwhile Revenue Department No.5051 dated the 30th January,2001, namely:-

Amendments

In the said notification in Article A, in part 1, for sub-clauses 1 (a) and 1(b), the following clauses shall be substituted, namely:-

- "1-A. Fees for registration of equitable mortgage by deposit of title deeds shall be at the rate of 0.5% of the value of consideration subject to maximum of two thousand rupees.
- 1-B. Fees for registration of deed of re-conveyance of mortgaged landed property for agricultural loans shall be at the rate of 1% of the value of consideration of documents subject to maximum of five hundred rupees.
- 1-C.Fees for registration of deed of re-conveyance of equitable mortgage for non-agricultural loan shall be at the rate of 1% of the value of consideration of the documents subject to maximum of five hundred rupees."
