## RESOLUTION

Sub:- Constitution of PMU Cell in Revenue & DM Department.

After careful Consideration, Government have been pleased to constitute a Project Monitoring Unit (PMU) Cell in R&DM Department keeping in view to monitor Online Mutation, 25- Point Parameter, Dynamic Web Information system for Tahasils (DWIST), Revenue Court Case Monitoring system,(RCCMS), Online saltamami. As per decision taken in 11<sup>th</sup> GB Meeting of Odisha Land Record Modernization Society(OLRMS) held on 23.09.2017 under the chairmanship of Chief Secretary following decisions were taken:

- (1) The PMU Cell will function under DILRMP Branch in R&DM Department under the supervision of Secretary of the Department.
- (2) The Joint Secretary or any Officer in charge of DILRMP Branch will supervise the PMU Cell. The existing ASOs working in DILRMP Branch will assist day to day Official Business of PMU Cell.
- (3) The manpower for handholding support for the PMU will be for Six months in Different Locations in all Districts and one year for Department. It will be extended as per approval by Government.
- (4) There will be a team leader along with a group of Programmers/ Asst. Programmers for monitoring as well as development, and up-gradation of Softwares.
- (5) One Assistant Programmer will be engaged in each District to provide the handholding support.
- (6) Three Programmers will look after the Development and One team leader will remain in charge of Overall Co-ordination.
- (7) The resource persons under PMU Cell will be through NICSI. That out of Interest money of OLRMS Rs.1,15,40,000/- (One crore, fifteen lakh and forty Thousand) will be utilized to meet the expenditure of PMU cell. Hence, no budget provision is required for PMU Cell at present.

(8) The function of PMU Cell may be extended on assessment of further achievement, if required.
