Sub: Holding of Camp Courts by Additional Tahasildars/ Tahasildars at R.I Offices for disposal of all revenue cases.

Sir,

In continuation of this Department letter cited above, I am directed to say that as the recommendation/observation of the Departmentally Related Standing Committee-X, 2017-18 of the O.L.A in their meeting held on 09.02.2018 under the Chairmanship of Sri Mahesh Sahoo, Hon'ble M.L.A had recommended to hold at least two number of Camp Courts in a month by the Additional Tahasildars at R.I. Offices, which is beyond 20 K.M.s distance from the Tahasil Office.

Accordingly, Government have been pleased to order that the Additional Tahasildars/ Tahasildars shall hold the Camp Courts at R.I Offices which is beyond 20 kilometers distance from the Tahasil office at least twice a month for speedy disposal of various revenue cases at the R.I offices level.

Besides, the Collectors are requested to ensure holding of Camp Courts by Additional Tahasildars/Tahasildars and furnish the Action Taken Report(ATR) in the enclosed prescribed format as at Annexure-A to this Department every month.
