Sub: Principles for lease of brackish water areas in the State- Modification thereof Ref: - This Department G.O No. 38800/ R&DM dated 27.08.2012

I am directed to say that this Department in the G.O under reference has laid down certain principles for lease of brackish water areas in the State. At Para 3 of the aforesaid G.O, the categories of parties/ persons in whose favour such lease can be granted have been specified.

- 2. Recently, Fisheries & ARD Department had submitted a proposal to this Department to include the "Aquaculture Companies" in the 2<sup>nd</sup> category of parties in whose favour such lease could be granted.
- 3. Government, after careful consideration of the aforesaid proposal of Fisheries & ARD Department have been pleased to include "Aquaculture Companies" in the 2<sup>nd</sup> category of parties in whose favour such lease will be granted.
- 4. Accordingly, Para 3 of the G.O cited above is modified as follows:-

"The parties/ persons in whose favour lease will be granted shall be categorized into two separate groups i.e. 1st category and 2nd category.

## 1st Category:

The lessee intended in the 1st category are again divided into two sub-groups such as Sub-Group-'A' and Sub-Group-'B'.

## Sub-Group - 'A'

The following persons are to be included in Sub-Group--'A'

- (a) Beneficiaries of anti-poverty programme
- (b) Persons under BPL category
- (c) Fishermen by profession or by caste
- (d) Landless persons having income not more than Rs.24, 000/per annum

(e) Marginal farmers

## Sub-Group-'B'

The following types of lessees are to be included in Sub-Group--'B'

- (a) Educated unemployed persons (Matriculation and above)
- (b) Self Help Group (SHG)
- (c) Primary Fishermen Cooperative Society (PFCS)
- (d) Women Cooperatives

## 2nd Category

The following types of lessees are to be included in the 2nd Category:-

- (a) Partnership firms
- (b) Technical entrepreneurs
- (c) State Owned Corporations
- (d) Aquaculture Companies"
- 5. This Department G.O cited above is modified to the above extent.
