Sub: Preferential allotment of homestead land to orphans and physically challenged individuals who leave recognised orphanages and special schools in the State.

I am directed to say that on the basis of proposal received from W & C.D. Deptt. in UOl. No. 798/SWCD Dt. 28.12.2005, this Deptt. has communicated the decision of Government vide G.O. No. 21097/ R Dt. 3.6.2006 addressed to Secretary. Board of Revenue, Orissa, Cuttack with copy to all concerned that while making allotment of Government land under OGLS Act and Rules for homestead purpose, preference should be given to orphans and physically challenged individuals who leave the Government supported orphanages and special schools and to consider their cases for allotment of house sites under the project 'Vasundhara'. A copy of such instruction has also been sent to your Deptt. vide this Deptt. Memo No. 21098/R Dt. 3.6.2006 (Copy enclosed for ready reference).

Now, Sri S. Paul Raj, Secretary, Society for Accelerated Development of Harijan and Adivasi Nationals (SADHAN), a N.G.O. based in Kandhamal district has submitted a representation to the Hon'ble Minister, Revenue & D.M. that the facility envisaged in the aforesaid G.O. may be extended to all recognised orphanages and special schools in the State. A copy of his representation is enclosed.

You are, therefore, requested to please examine the contention made in the representation and make available the considered views of W&CD Deptt. in the matter to this Deptt. at an early date for further action at this end.

Sub: Allotment of homestead land to orphans and physically challenged individuals who leave the Government supported orphanages and special schools on reaching the age of 18 in case of boys and 25 in case of girls.

Madam.

A proposal was received from the Women & Child Development Department for preferential allotment of Government land for homestead purpose under Orissa Government Land Settlement Act, to orphans and physically challenged, who leave the Government supported orphanages and special schools on reaching the age of 18 in case of boys and 25 in case of girls.

it may be mentioned here that there are 85 Government orphanages with a total sanctioned inmate strength of 5293 maintained by NGOs as well as Government Organisations and 81 Government supported special schools (for physically challenged) with total sanctioned inmate strength of 4148 (50 special schools funded by the State Government + 31 schools funded by the Government of India). The list of such institutions is enclosed herewith for ready reference.

Barring rare exceptions, the orphans and physically challenged persons are homeless. They are, therefore, eligible for allotment of homestead land under OGLS Act and Rules.

After careful consideration, Government have been pleased to decide that while making allotment of Government land under the OGLS Act and Rules for homestead purpose, preference should be given to orphanis and physically challenged individuals who leave the Government supported orphanages and special schools and to consider their cases for allotment of house sites under the project "Vasundhara". Accordingly, subordinate offices may be instructed suitably

However while disposing of such cases the competent authorities may not allot house site to any of them if found otherwise ineligible.
