Sub: Utilization of government land leased out/ advance possession sanctioned in favour of Central Government/ State Government Departments, Organizations/ Institutions and other Organizations/ Institutions

Madam/Sir,

I am directed to say that meetings were held in the Conference Hall of this Department on 03/04/2018, 04/04/2018 and 05/04/2018 with participation of officers of different districts alongwith the dealing Assistants on 'Management of Minor Mineral Sources and "Protection of Government Land".

- 2. In the said meetings, it has been decided, inter alia, that all Collectors shall cause a review of the cases where government land has been settled with Organizations/ Institutions as to whether the settled land is being properly utilized or being utilized for a purpose other than the purpose for which it was settled and also the cases where advance possession have been sanctioned and furnish detailed report to the Department by 30th April, 2018. The Department will prescribe a Format for the purpose at the earliest.
- 3. In this context, you are requested to furnish aforesaid information in the following Format to this Department by 30/04/2018. The information should include lease/ alienation/advance possession of government land sanctioned in favour of Central Government/ State Government Departments, Corporations, Organizations, Institutions etc. and also private Organizations, Institutions etc.
- 4. The required information should be furnished to the Department both in word/ excel File, (not in pdf. Format) in e- Mail ID- <a href="mailto:lrge-rev.od@nic.in">lrge-rev.od@nic.in</a>.
- 5. While submitting the information, the abstract of the figures should also be given.
