
No. GE (GL) S-4/2010/ *14137* /R&DM dated 28<sup>th</sup> March, 2011

Whereas the period of limitation provided under para (i) of the proviso to clause 1 of Schedule V of the Orissa Government Land Settlement Rules, 1983 was extended for a further period of six months with effect from 17<sup>th</sup> August, 2010 under the notification of the Government of Orissa in the Revenue Department No. No. GE (GL) S-4/2010/ 40225 /R&DM dated 29<sup>th</sup> September, 2010;

And whereas, the State Government are satisfied that there exists sufficient reasons for further extending the period of limitation as so extended;

Now, therefore, in exercise of the powers conferred by para (i) of the proviso to clause 1 of Schedule V of the Orissa Government Land Settlement Rules, 1983, the State Government do hereby extend the period of limitation by a further period of six months with effect from the 17<sup>th</sup> February, 2011.






