**RESOLUTION**

**Sub:- Constitution of Committee to recommend maximum extent of government land to be allotted to educational institutions on free of premium basis**

The present policy of allotment of government land to educational institutions have been laid down in erstwhile Revenue Department G.O No. 20615/R dated 19/03/1976, G.O No. 38870/R dated 23/05/1977 and G.O No. 62250/R dated 26/11/1998. While the G.O dated 19/03/1976 and dated 23/05/1977 specify the extent of government land to be allotted on free of premium basis to educational institutions, the G.O dated 26/11/1998 stipulates the number of High Schools and Colleges which would be eligible to get such land on free of premium basis.

2. In the meantime, government land has become scarce and demand for such land for various developmental and infrastructure purposes is increasing. Hence, it is felt necessary that the aforesaid policy of allotment of government land to educational institutions should have a revisit.

3. Keeping the above in view, Government, after careful consideration, have been pleased to constitute a Committee with the following composition which will revisit the existing policy of Revenue & D.M Department and recommend to Government the maximum extent of government land to be provided to educational institutions in the State on free of premium basis.

1.	Director, Higher Education, Odisha	Chairperson
2.	Director, Secondary Education, Odisha	Member
3.	Joint Secretary to Government (in charge of LR&GE Branch), Revenue & DM Department	Member-Convener

4. As directed by Government, the Committee shall submit its recommendation to Revenue & D.M Department within a month of its constitution.


