Sub: Furnishing of information to comply with the order of Hon'ble Supreme Court passed in WP (C) No. 50/ 2008 (Wildlife Trust of India & ors.-vrs- Union of India & ors.)

Madam/ Sir,

In enclosing a copy of the order dated 07/03/2018 passed by the Hon'ble Supreme Court in WP (C) No. 50/ 2008 (Wildlife Trust of India & ors.-vrs- Union of India & ors.), I am directed to say that the Hon'ble Court has directed all State Governments to file a tabular statement in the form of an affidavit indicating the following:-

- (i) The number of claims for the grant of land under the provisions of the ST & OTFD (RFR) Act, 2006;
- (ii) The claims should be divided into claims made by the Scheduled Tribes and separately by other traditional forest dwellers;
- (iii) The number of claims rejected by the State Government in respect of each category;
- (iv) The extent of land over which such claims were made and rejected in respect of each of the two categories
- (v) Action taken against those claimants whose claims have been rejected;
- (vi) The status of eviction of those claimants whose claims have been rejected and the total extent of area from which they have been evicted;
- (vii) The extent of the area in respect of which eviction has not yet taken place in respect of rejected claims.

2. As directed by the Hon'ble Court, the cut- off date for providing this information is **31/12/2017**.


3. In this context, you are requested to furnish the **required information in respect of forest KISSAM of land coming within the jurisdiction of R&DM Department** directly to ST & SC Development Department in the enclosed Format with copy to this Department as well as

to Forest & Environment Department so as to enable the ST & SC Dev. Department to file a compiled report before the Hon'ble Apex Court.

4. The report should reach all quarters **by 15th May, 2018** without fail.


