Sir,

With reference to the subject noted above, I am directed to say that as per information available in the Department, the Odisha State Co-operative Marketing Federation Ltd. (MARKFED) has filed requisition for lease of government land at ten locations in as many districts as detailed below for construction of buffer godowns for fertilizer pre-positioning under RKVY funding.

2. For such lease of land, MARKFED, which is an apex Cooperative society, is required to pay premium and incidental charges as one-time payment and ground rent and cess annually. As intimated by Co-Operation Department in the UOI under reference, MARKFED is not in a position to bear the financial burden towards payment of the above dues.

- Keeping the above in view, Government, after careful consideration, have been 3. pleased to decide that the government land at the locations detailed above shall be alienated in favour of Co-Operation Department for construction of buffer godowns by MARKFED for fertilizer pre-positioning under RKVY funding. As per rule 283 (1) of the Odisha General Financial Rules, Volume-I, such transfer of government land in favour of a Department of the State Government shall be free of all charges and as per the delegation of powers made under Schedule II of the OGLS Rules, 1983, the RDC or Collector, as the case may be, shall be competent to sanction settlement of such extent of government land in favour of a Department.
- Hence, the Co-Operation Department may duly authorize an officer/s of their 4. Department (at the Department level or at the field level) who may file requisition for alienation of the lands before concerned Tahasildars and after sanction of alienation of the lands in favour of Co-Operation Department, the Department may allow MARKFED to construct the godowns on such lands.
