**Sub: Approval of mining plan for quarry Leases**


Madam/ Sir,

This supersedes the letter No. 29814 dtd. 10.10 2014 of Revenue & DM Department.



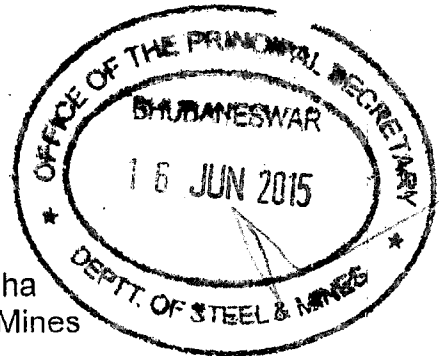

**NOTIFICATION**

Whereas, the Government are of opinion that it is desirable to specify ceiling rates on fees chargeable by the RQPs recognized under rule 2(u1) of the OMMC Rules,2004 for preparing mining plans for quarry leases in order to remove problem in preparation of such plans;

Therefore, after careful consideration of the matter, the Government have been pleased to decide that ceiling of fees chargeable by the Registered Qualified Persons (RQPs) is hereby fixed at Rs.40,000/- for quarry leases of an area upto Ha.5.00 and Rs.5,000/- per hectare for area in excess of Ha.5.00. This would be the ceiling rate and lesser amount can be negotiated by the parties.
