

In continuation of this Department letters cited above, I am directed to enclose herewith the letter No. 10704/SSD dated 26.06.2019 of ST and SC Development Department and say that the State Government have decided to extend reservation for admission to specified educational institutions in the State of Odisha to the Economically Weaker Sections (EWS) candidates **who do not belong to the ST, the SC and the SEBC (State List) categories.**

The format for issue of Income and Asset Certificate for the purpose is enclosed herewith as **Annexure-'A'**. All other provisions contained in this Department Letter No.9208 dt.18.3.2019 shall apply *mutatis mutandis* for the purpose of issue of Income and Asset Certificate.

Sub.:-Issuance of Certificate for Economically Weaker Sections (EWSs) in Admissions in specified Educational Institutions under Government of Odisha.

Ref: This Department letter No. 5097/ SSD dated 10.03.2019

Sir,

In inviting a reference to the subject cited above, I am to say that the Health & Family Welfare Department have taken approval of Government for providing 10% reservation to Economically Weaker Sections (EWSs) in admission to 3 Medical Colleges under the State Government. The Ministry of Personnel, Public Grievances & Pensions, the Ministry of Human Resources Development and the Ministry of Social Justice Empowerment had earlier issued guidelines for issuance of Income and Asset Certificates for EWS candidates seeking reservation in recruitment in civil posts and services and admissions in educational institutions under Government of India. However, there is a need to issue specific guidelines to the certificate issuing authorities for issue of Income and Asset Certificate to eligible EWS candidates seeking admissions in educational institutions under Government of Odisha.

Accordingly, the following modifications in the Income and Asset Certificate are suggested.

I. The Para No.2 of the Income and Asset Certificate may be modified as follows:

"2. Shri/ Smt./ Kumari _____ belongs to the _____ caste which is not recognized as a Scheduled Caste, Scheduled Tribe and Socially and Educationally Backward Classes (State List)".




II. In the Income and Asset Certificate, Para.3 may be inserted as follows:

" 3. This certificate is being issued for the purpose of admission to Specified Educational Institutions in the State of Odisha, notified by Government of Odisha, from time to time " .

In this regards, necessary guidelines may kindly be issued to the certificate issuing authorities for issue of Income and Asset Certificate to eligible EWS candidates seeking admissions in educational institutions under Government of Odisha.

This has been concurred by Law department in file No. EMP-I (A)-9/2019; STSCD-RP-POLICY-0003-2019.
