No. Regn-13/2008- **17970** / R&D.M., In exercise of the powers conferred by sub-clause (6) of clause (9) of Section -2 of Indian Stamp Act, 1899 (2 of 1899) and in partial modification of the Government of Orissa in the Revenue and Disaster Management Department Notification No. 21063/R&D.M., dated 1.6.2007, the State Government do hereby authorize the Sub-Registrar, Khurda, as a special case to exercise the powers of the Collector under Section 47-A of the Indian Stamp Act as mentioned in the schedule below.

**SCHEDULE**

<b>Existing provision as per this Department's Notification No. 21063/R&amp;D.M. dt. 1.6.2007</b>	<b>The amended provision as per this Notification</b>
He will refer the under valuation cases under Section 47-A to the District Sub-Registrar, Khurda in respect of documents where the consideration or market value set forth in the documents is upto Rs. 60,000/- (Rupees Sixty thousand) only and he is required to refer the under valuation cases to the Sub-Collector, Khurda in respect of documents where the consideration or market value set forth is more than Rs. 60,000/- but upto Rs. 1,20,000/- (One lakh and twenty thousand) only.	He will refer the under valuation cases under Section 47-A of the Indian Stamp Act to the Sub-Collector, Khurda in respect of documents where the consideration or market value set forth in the document is upto Rs. 1,20,000/- (Rupees One lakh twenty thousand) only.

All other terms and conditions mentioned in the Notification No. 21063/R&D.M. dt. 1.6.2007 stand unaltered.
