**Sub: Provision of MPLS connectivity to all tahasils.**

Sir,

In inviting reference to the minutes of the meeting on OSWAN connectivity in Revenue offices held on 1<sup>st</sup> May 2017 at 4:30 PM communicated vide this Department letter no. 18475 dated 05.06.2017, I am enclosing herewith the list of Tahasils (Annexure-1, 2 & 3) to which MPLS connectivity of 2 Mbps bandwidth should be provided in a phased manner within 4 months for disposal of mutation cases through online mutation software (LRMS). E&IT Department may place the funds with BSNL authorities within 15 days to take up the work on war-footing basis. Deputy General Manager (EB) BSNL, Odisha Telecom Circle has sent a demand note of Rs 11,19,691/- for providing 2 Mbps MPLS VPN (Gold) connection to 7 Tahasils (Khurda, Jatani, Chhatrapur, Nayagarh, Boudh, Jharsuguda and Phulbani) where e-Mutation has been rolled out on pilot basis. The copy of the same is enclosed as Annexure-4. The funds may please be placed with BSNL authorities as demanded along with funds for providing connectivity to other Tahasils. The MPLS connectivity for the phase-I may be provided within one month, phase-II within 2 months and phase-III within 4 months.

This work may please be taken up on priority basis for effective delivery of public services in Tahasil offices.


