No. RDM-LRGEA-STATUT-0003-2018- 21125 Dated the .11 JUN 2018

In exercise of the powers conferred by section 8 of the Odisha Government Land Settlement Act, 1962 (Odisha Act 33 of 1962) the State Government do hereby direct that the power exercisable by it under section 3 of the said Act for the purpose of settlement of government land in favour of project proponents for establishment of tourism units under the Odisha Tourism Policy, 2016 as may be modified, from time to time, shall also be exercised by the Collectors within their respective jurisdiction.

Applications relating to tourism units pending with the State Government, if any, shall be transferred to the concerned Collectors.


