II. Setting up of temporary stalls/shops including road side shops and stalls on specific occasions for sale of materials:-

(a) Minimum of Rs.100/- (Rupees One hundred) only up to 100 Sq.ft. and Rs.10/- (Rupees ten) only for each additional 10 Sq.ft. or part thereof per day.

(a) Rs.20.00 (Rupees twenty).

(b) Towns mentioned as Category 'B' in the Annexure.

(b) Minimum of Rs.60/- (Rupees sixty) only up to 100 Sq.ft. and Rs.6/- (Rupees six) only for each additional 10 Sq.ft. or part thereof per day.

(b) Rs.17.50 (Rupees seventeen and fifty paise).

(c) Towns mentioned as Category 'C' in the Annexure.

(c) Minimum of Rs.40/- (Rupees Forty) only up to 100 Sq.ft. and Rs.4/- (Rupees four) only for each additional 10 Sq.ft. or part thereof per day.

(c) Rs.15.00 (Rupees fifteen only).

(d) Rural areas.

(d) Minimum of Rs.25/- (Rupees Twenty five) only up to 100 Sq.ft. and Rs.2.50 (Rupees two and paise fifty) only for each additional 10 Sq.ft. or part thereof per day.

(d) Rs.10.00 (Rupees ten).
