No. PTI-RDM-CHS-SCH-0050-2017²¹⁷⁰⁹ /R&DM, In pursuance of G.A &P.G. Department Notification N.12302/SCS, dated 01.05.2018 and in exercise of the powers conferred by Section-33 of the Odisha Survey & Settlement Act, 1958 (Odisha Act-3 of 1959), the State Government do hereby delegate the powers of the Board of Revenue, Odisha, Cuttack under Section -6D, 15 & 25 of the said Act in favour of Sri Chandramani Badnayak, OAS(SAG) as Additional Commissioner , Additional Revisional Court, Bhubaneswar.

He shall exercise the powers and perform the duties under the above provisions in respect of Bhubaneswar Sub-Division under Khordha district and Gop Tahasil under Puri district for disposal of revisional cases on transfer from the Court of Member, Board of Revenue, Odisha, Cuttack.
