Sub: Enumeration of Homesteadless and Landless families.

Sir/ Madam,

In inviting reference to this Department letter No.2277 dated 15.1.2004 on the above mentioned subject, I am to say that you were requested therein to enumerate the homesteadless families of your district and to furnish report to that effect by 10.4.2004. But required report in this regard is yet to be received from most of the districts.

2. In the meantime Government have decided to take up enumeration of both homesteadless and landless families in the state with a view to preparing an action plan to cover them within a definite time-frame.

3. You are, therefore, requested to issue suitable instructions afresh to the Tahasildars of your district to take up enumeration of homesteadless and landless families in their respective Tahasils. To make the work smooth and also to ensure an erro-free enumeration it is desirable that the local P.R.Is be involved /associated with the process of enumeration.

4. In any case the above exercise should be completed in all respects and consolidated report of the district furnished to this Department latest by 14.8.2004 in the enclosed proforma indicating the no. of homesteadless /landless families and extent of Government waste land available for house-site and Government waste land including ceiling surplus land and excess Gochar land available for agriculture purpose separately.

5. Follow up action taken in this regard may please be intimated to this Department by 14.6.2004 for information of Government. This may be treated as extremely urgent.
