Sub: **Principles for lease of brackish water areas in the State**

Ref:- This Department Letter No. GE (GL)-S-29/2015-16538 dated 03.06.2015

Sir,

In continuation to this Department Letter under reference, I am directed to say that the Government after careful consideration has been pleased to further decide as follows;

1. Brackish water prawn cultivation can be taken up in the areas between 0.5 km to 2 km of HTL, subject to permission of the Coastal Aquaculture Authority.
2. Cultivation of L. Vennamei can be taken up in areas between 2 km to 5 km, subject to the guidance issued by Ministry of Agriculture and Department of Animal Husbandry, Dairying & Fisheries of Government of India vide Notification No. 35029/13/2010 FY dated 21.12.2011.
3. The area beyond 2 km of HTL identified as clusters should be taken up only after spot verification by the Collector, Hydrology Department and also consultation of local people.
4. On receipt of verification certificate from the above authorities, the Director, Fisheries will issue permission for aquaculture to the farmers and ensures development of healthy aquaculture without allowing saline ingress affecting the agriculture.
5. For lease of land for brackish water aquaculture, permission from competent authority as above has to be obtained and such permission shall form the part of lease application.

Suitable instructions may accordingly be issued for the guidance of the field officers.
