RESOLUTION

Dated, Bhubaneswar, the 21/5/94 1994.

Sub: Upgradation of one of the posts of Deputy Inspector General of Registration to the post of Joint Inspector General of Registration.

The All Orissa Registering Officer's Association has been demanding from time to time upgradation of the post of Deputy Inspector General of Registration attached to the Office of the Inspector General of Registration to that of Joint Inspector General of Registration in the scale of pay of Rs. 3200-100-4700/-.

Government after due consideration of the demands of the Association and keeping in view the administrative necessity of having an Officer in the rank of Joint Director Level-II at the directorate level for a close-supervision of the working of Registration Offices in the field have been pleased to decide as follows :-

- (1) The post of D.I.G.R. attached to the Office of the I.G.R., Orissa, Cuttack is upgraded to that of Joint Inspector General of Registration in the scale of pay of Rs. 3200-100-3700-125-4700 with other allowances as admissible from time to time.
- (2) The joint I.G.R. will act as an adviser to the I.G.R. in administrative and technical matters of Registration.
- (3) The Joint I.G.R. will remain under the direct administrative control of I.G.R. He will co-ordinate the work of Deputy I.G.R.s. He will also perform such other duties and functions as may be assigned to him by Government or by the I.G.R. from time to time.
- (4) The Joint I.G.R. will undertake monthly monitoring of disposal of under valuation cases and will keep the I.G.R./Government informed of the position.

The Joint I.G.R. will enjoy the powers of inspection both of technical and administrative matters of the Registration Offices within the State.

The above decision of Government will come into effect from the date of issue of this Resolution.

The post of D.I.G.R. attached to the Office of the I.G.R. will continue till the higher post of Joint I.G.R. is filled-up.
