
No. RDM-LAB-GM-0002-2018- 23578 /R&DM, Dated 29/6/2018

The State Government, after careful consideration and in partial modification of the decision communicated under the notification of the Government of Odisha in the Revenue and Disaster Management Department No. LA (B)-14/2005-GM-40586/R&DM dated the 09th October, 2007, have been pleased to decide that out of the total Ac.2970.00 of land handed over to IDCO at Gopalpur in Ganjam District, Ac.1235.00 of land notified by the Central Government as Special Economic Zone will be utilized by M/s Tata Steel Special Economic Zone Ltd. (M/s TSSEZL) for that purpose and the balance Ac.1735.00 of land will be utilized by M/s TSSEZL for setting up a private Industrial Park as Domestic Tariff Area subject to the following conditions:-

- (a) the Company shall be liable to make payment of any claim for compensation by any land loser towards R&R benefit as assessed by competent authorities or by orders of any Court of Law and any legal expenses arising out of court cases and the same shall not be a liability of the State Government;
- (b) the total timeline for implementation of the proposed Industrial Park and the Special Economic Zone shall not be more than 5 years from the date of issue of this notification;
- (c) M/s TSSEZL will explore the possibility of reducing the land price to make it attractive for the investors and Industries Department will be appraised of the pricing model.

2. The State Government have also been pleased to allow M/s TSSEZL to further sub- lease the Ac.1735.00 of land, which is to be utilized for setting up the private Industrial Park as Domestic Tariff Area, to other industrial units.
