No. GE (GL) S-13/2014- 23934 /R&D.M dated 13.8.14

Whereas the period of limitation provided under para (i) of the proviso to clause 1 of Schedule V of the Odisha Government Land Settlement Rules, 1983 (hereinafter referred to as the said rules) was extended for a period of one year with effect from the 17th February, 2013 under the notification of the Government of Odisha in the Revenue and Disaster Management Department No. GE (GL) S-9/2013-6808/R&DM, dated the 25th February, 2013 published in the Extraordinary issue of the Odisha Gazette No.412 dated the 14th March, 2013;

And whereas the State Government are satisfied that there exists sufficient reasons for further extending the period of limitation as so extended;

Now, therefore, in exercise of the powers conferred by para (i) of the proviso to clause 1 of Schedule V of the said rules, the State Government do hereby extend the period of limitation by a further period of two years with effect from the 17th February, 2014.


