RDM-CHS-PGVIP-0002-2016-23966/RDM. In exercise of powers conferred by section-33 of the Odisha Survey & Settlement Act, 1958 (Odisha Act 3 of 1959) and in partial modification of this Department Notification No.20493, dated 15.07.2015 (published in the extraordinary issue of the Odisha Gazettee vide S.R.O. No. 326/2015) the State Government hereby delegate the powers of the Board of Revenue, Odisha under Section-6D, 15 & 25 of the Act in favour of the Collectors, Koraput, Nawarangpur, Rayagada, Malkangiri, Nuapada and Kalahandi districts who shall exercise the powers and perform the duties under the above provisions in their respective districts in addition to their own duties for the purpose of early disposal of the revision cases.

The revisional power earlier delegated in favour of R.D.C (SD), Berhampur in respect of the districts i.e Koraput, Nawarangpur, Rayagada and Malkangiri vide this Department Notification No.27874/R&DM, dated 30.09.2015 (published in the extraordinary issue of Odisha Gazette vide S.R.O. No.471/2015) is hereby withdrawn.
