In inviting a reference to the subject cited above, I am directed to say that the Government has been pleased to approve rolling out of online Manual of Tahasil Accounts (MTA) application from 1st August, 2018.


It is mentioned here that all Tahsildars were already given training on MTA application at ROTI, Gothapatana, Bhubaneswar on 1st, 5th and 12th June, 2018 RDC wise separately. It was also decided that the Tahsildars/ Additional Tahsildars who attended the training programme will be the Master Trainers of MTA application software and they will impart training and assist the RIs and Amins while during data entry in MTA application.

The step by step procedure for making data entry in the application with screen shots were already communicated to you vide this Department letter No. 19661 dated 30.05.2018 for kind reference of the Tahsildars. The screenshot of the Tenant Ledger and Receipts is also attached herewith for kind reference of Tahsildars.

It is also decided that the RI login ID and password of all RIs in your district will be communicated through DIO,NIC and Asst Programmers by mail for security reason.


You are, therefore, requested to kindly instruct all the RIs under your administration to populate data in MTA application software from 15TH July,2018.
