
Subject: Constitution & functioning of State Monitoring Committee for Rehabilitation and Resettlement

As per provisions under Section 50 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, and, Rule 37 of the Odisha Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Rules, 2016, the State Monitoring Committee for Rehabilitation and Resettlement related to land acquisition is hereby constituted as follows:

3. Terms of Reference of the State Monitoring Committee for R&R shall be to review and monitor the implementation of rehabilitation and resettlement schemes or plans under the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 and R&R Plans prepared under the Odisha Resettlement and Rehabilitation Policy, 2006.
4. The non-official members will be paid TA / DA by the Department of Revenue & Disaster Management Department as per Government of Odisha Rules.
5. The Committee shall meet at least once in every year.


