NOTIFICATION

No.RDM-LRGEA-STATUT-0005-2018-24953 /R&DM Dated 22 AUG 2019

Whereas under para (i) of the proviso to clause 1 of Schedule V of the Odisha Government Land Settlement Rules, 1983, for settlement of land, applications were required to be submitted within a period of six months from the date of publication of the Odisha Government Land Settlement (Amendment) Rules, 2010;

And whereas, the period of limitation was last extended for a period of one year and two months with effect from the 17th February, 2018 under the notification of the Government of Odisha in the Revenue and Disaster Management Department No. 30939-RDM-LRGEA-STATUT-0005-2018, dated the 21st August, 2018 published in the Extraordinary issue of the Odisha Gazette No. 1545, dated the 23rd August, 2018;

And whereas, the period of limitation last extended has expired on the 16th April, 2019;


And whereas, it has come to notice that a number of applicants are still awaiting to apply for settlement of the land of the categories mentioned in sub- clauses (a) and (b) of clause 1 of Schedule V of the Odisha Government Land Settlement Rules, 1983;

And whereas, unless the time limit is extended, a number of applicants shall be debarred from getting such land settled with heritable and transferable rights;

And whereas, the State Government are satisfied that there exists sufficient reasons for extending the said period of limitation;

Now, therefore, in exercise of the powers conferred by para (i) of the proviso to clause 1 of Schedule V of the Odisha Government Land Settlement Rules, 1983, the State Government do hereby extend the said period by a further period of eleven months and 15 days with effect from the 17th April, 2019.
