Sub: Disposal of Mutation Cases pending in different Tahasils and registration of documents - instructions thereof


Sir,

In continuation to this Deptt. letter no. 19915 dtd. 08.07.2014, I am to say that during my review meeting with ADMs and District Sub-Registrars on 23.08.2014, it has come to the notice of the Government that the registering officers are refusing to register the documents on the ground of non-presentation of RORs as the mutation including correction of records, issuance of RoRs and uploading in *Bhulekh* is to be attended within the stipulated time frame of 90 days in all uncontested Mutation Cases.

As the Controlling authority, you are requested to take all precautionary measures and activate the machinery not to commit delay in effecting mutation in Record of Rights and issuance of up-to-date RoRs. This results in non- delivery of services within the time frame as prescribed under the Odisha Right to Public Services Act, 2012 for which daily fine of Rs. 250/- in case of violation has been provided.

You are, therefore, requested to ensure implementation of the legal provisions reiterated above in letter and spirit. Action should be initiated instantly in case of any dereliction of duties in dealing with mutations under major penalty proceeding under CCA Rules.




