In exercise of the powers conferred by section 78 read with section 79 of the Registration Act, 1908 (Act. 16 of 1908), the State Government do hereby direct that the following amendment shall be made in the notification of the Government of Odisha in the erstwhile Revenue Department No. 5051 dated 30th January, 2001.

Amendment
