OFFICE ORDER

Sub: e-Governance initiatives of Revenue and DM Department.

Government in Revenue and Disaster Management Department is committed to timely and hassle free delivery of public services notified under the Odisha Right to Public Services Act, 2012. Various e-Governance initiatives have been taken up by the Department to achieve this objective. Out of 31 (thirty one) public services pertaining to Revenue and DM Department, 22 (twenty two) services are delivered electronically through e-District Portal, e-Registration Application and e-Mutation Application (LRMS).

The following activities shall be undertaken by the Department to monitor the timely delivery of public services:

- 1. The PMU set up in the Department shall develop an application software with which the e-District Application, e-Registration Application, LRMS (Land Records Management System (LRMS) and Revenue Court Case Monitoring System (RCCMS) etc. shall be integrated. The PMU and the System Integrators of the respective web applications shall take steps to complete this task by 20th July, 2018.
- The System Integrators for e-District Application i.e. SRIT, for e-Registration Application i.e. IL&FS Technologies Ltd. and for LRMS and RCCMS i.e. NIC, Bhubaneswar shall take expeditious steps to complete necessary integration works within the above time line.
- The daily status on disposal of cases by the Designated Officers and the pendency of cases beyond ORTPS time line (both service-wise and office-wise) shall be made available on real time basis in the dashboard of the proposed centralised application software by 31st July, 2018.
- A "Daily ORTPS Bulletin" shall be published by the PMU of the Department by <u>15th</u>
 August, <u>2018</u>. The same shall be displayed publicly and sent to the concerned Designated Officers.
- The Department shall take steps for automation of 9 (nine) public services (those are presently delivered manually) and their electronic delivery by 3^{1st} August, 2018.
- 6. Point of Sale (POS) machine shall be installed in all Tahasil and Registration offices as per the guidelines communicated by the Finance Department for digital payment of revenue dues, stamp duty, registration fees and other fees to encourage cashless payment by the Citizens.
- 7. The Department shall take steps for integration of Bhulekh application with the payment gateway of the Odisha Treasury Portal (IFMS) by 31st July, 2018 for online payment of revenue dues and other dues payable to Government.

shall be completed by 31st August, 2018 to enable the Citizens to pay the revenue
dues and other Government dues online.
